Jacob Barnes Timeline in Isle of Wight Co., Virginia, and People Associated with Him

- c.1649 **Probably London, England. Jacob Barnes** was born. His parents were **Edward Barnes** and **Mary Mills** if the article about Jacob is accurate. [Thomas Barnes of Isle of Wight Co., VA, a possible brother or other relative, was born bef 1645] Jacob gave his age, 43-44, in a deposition of 09 Feb 1692 (see below).
- c.1677 **England to America.** Jacob Barnes emigrated at about this time according to *The Virginia Magazine of History and Biography*.³ The source stated that he visited his brother in England in 1709 after an absence of 32 years.
- c.1680/1685 Edward Barnes, who married Sarah Pope, was born. This Edward Barnes appears to be the son of this Jacob Barnes of Isle of Wight Co., VA, because Jacob Barnes was a member of the same Quaker meeting as Sarah Pope, and he witnessed the will of William Frizzell, which mentions Frizzell's granddaughter, Susan Pope—the sister or half-sister of Sarah Pope. (Edward died in 1762 in Edgecombe Co., NC.)
- 20 Apr 1684 **Lower Norfolk Co., VA. Mr. Jacob Barnes**, 215 acres at head of the south branch of Eliz River called Barnes' Neck. Beg in the Gum Swamp & adj. Mr. Mathew Whitfield, trans of 5 persons: Jon. Wells, Cobb Howell, Xpher. Nugent, Ed. Broughton, Wm. Hunt. 4
- 27 Apr 1686 **Lower Norfolk Co., VA.** Capt. Wm. Knott, 1050 acs., from head of the S. Br; Patent Book 7, p. 501. Beg. by a gr. Cyprus Sw., cor. of **Jacob Barnes**; to Sylvester's lyne; to mouth of Gum Sw. &c. Trans. of 25 pers. [Nansemond Co. was originally called **Upper** Norfolk Co.]
- 20 Apr 1687 **Isle of Wight Co., VA. Jacob Barnes**, "liver in ye Isle of Wight County," received a grant of 250 acres near the head of the Southern Branch of the **Elizabeth River, Lower Norfolk County**, Virginia, adjoining his own land. Beg at John Corporice, by the Cypress Swamp, in Sylvester's line &c. Trans of 5 Persons: Rich. Page, David Magason, Emma Henton, Fran. Hobson, John Thomas.⁶
- 23 Apr 1688 **Lower Norfolk Co., VA.** Richard Silvester, 300 acs., towards head of the S. br. of Eliz. Riv. Beg. at land he bought of Whittfield; to land of [Jacob] **Barnes**, now John Smith's, & adj. on lands of Tayler, Platt, Costen & Jno. Corporue. Trans. of 6 pers: Richd. Silvester, Isaac Bernop, Hannah his wyfe, Isaac Bernip, John Johnson, John Collah.⁷ (p. 642)

- 20 Oct 1691 **Norfolk Co., VA.** Capt. Hugh Campbell, 250 acs., from head of the S. br. of Eliz. Riv., in Low. Norf. Co. at time of the grant, but now Norf. Co., Patent Book 8, p. 203. Adj. John Corperue, & Selvester's line. Granted **Jacob Barnes** 20 Apr 1687, deserted, & now granted by order &c. Imp. of 5 pers....¹¹
- Isle of Wight Co., VA. The Deposition of Jacob Barnes aged between forty three & foure sayth that being at ye house of Mr Wm Smith Sen. upon ye 26th day of December last, yt two of Mr Styles his men named Sam Leyburn & Cha. Evans did there say yt Mr Richd Wilkinson Senr was a going to Corte & yt ye sd Wilkinson had a bag of tobo stalke, did intend to carey ym to Court in order to prove yt col. Jno Pitt did make second crops of tobo & after ye above mentioned two men were gone, Mr Styles himselfe did come to ye same house, & did there say to ye Depont ye same words & ye sd Styles did further declare yt ye sd Wilkinson has carried ye sd Stalkes to Court, if He had not disswaded him from soe doing & further sayth no. Jacob was aged 43 (born 1649) when he made a deposition concerning a will of Mr. Samuel Burknell, part owner of the Brigantine Mary and Dorothy, 6 Feb 1692. Also making depositions were Arthur Smith (55), Arthur Smith Jr. (25), Richard Williams (28), Wm. Smith (58) and wife Mary (no age given) (17th Cent Isle of Wight.¹⁴

09 Dec 1693 **Isle of Wight Co., VA. Jacob Barnes** was a witness with Eliz Altman and Danl Miles, for a deed of John Parker and wife Mary to "brother" Francis Parker. Land on the western side of

- Isle of Wight Co., VA. William Smith (II): Leg. wife Mary; son William the land he and John Batten live on, adj. Thomas Altman and the widow Weston; son Nathaniel the plantation called Jones', where John Altman lives; son Nicholas the plantation on which Thomas Bulger lives, also all the land between it and Major Burwell, Bagnall and Parker; son Joseph the plantation on which the widow Franklyn lives; daughter Ann Weston; Elizabeth Parker, Sarah Bulger; granddaughter Ann Barnes. [It appears that Jacob Barnes was married to a daughter of William & Mary Smith, who was dead by 1704, and Ann may have been Jacob's granddaughter.]

Thomas Boulger was married to Sarah Smith (dau of William and Mary Smith); Sarah Boulger and both of her parents left wills in Isle of Wight naming a granddaughter (and niece) as Anna Barnes - another of the Smith daughters, Ann, had married a Wesson (Weston) (see wills of Isle of Wight). Thus Jacob Barnes was very involved with the Smith family, perhaps having married a Smith.²¹

"Whether these are for the same man or not is unknown. That the names Jacob Barnes and Joshua were used by descendants of the other Barnes families in that section makes it likely that there was some relationship." 30
