

Burtons in Buckingham County, Virginia

Buckingham County appears to have been named after the Duke of Buckingham in Buckinghamshire, England and was **established on May 1, 1761 from the southeastern portion of Albemarle County**. In 1778 a small triangular area bordering the James River was given to Cumberland County. In 1845, another part was taken from Buckingham to form the northern portion of Appomattox County. A final adjustment of the Appomattox-Buckingham county line was made in 1860 and Buckingham's borders then became fixed in their current form. Thomas Jefferson was the architect of the court house which was destroyed by fire in 1869. Most of the records were lost.

c.1760 **Buckingham Co., VA. Robert Bolling**, of "Chellowe," was born at Varina, Henrico Co., on 17 Aug 1738 and died in 1775. He married first **Mary Burton**, daughter of **William Burton & Margaret Robins**, of Northampton Co., and second in 1765 **Susannah Watson** in Amherst Co.¹

24 Mar 1764 **Buckingham Co., VA. William Baber**, 400 ac.; both sides great creek of Slate River and Freeland's Lick Branch; his own land, **Sampson Maxey, Isaiah Burton**, neighbors.²

1764 **Buckingham Co., VA. Tithables.**³ Names in parentheses are probably slaves.

c. 1770 **Buckingham Co., VA. "Mrs. Elizabeth Dibrell**, first wife of **Anthony Dibrell**, died at the age of 36, having been married only 14 years. After the death of his first wife, Anthony Dibrell married the second time, **Miss Magdaline Burton**. There were no children by this marriage. Anthony Dibrell died in 1800, aged 73 years. His second wife survived him, having died in 1806."⁴

04 Mar 1779 **Madison Co., KY.** The will of **Peter Ford**, who had left Buckingham Co., VA, was signed. It was proved 05 Oct 1801. **Hutchins Burton** was a witness, with **John Manier, Christopher Coy, Elisha Coy.**¹²

c.1775-1783 **Buckingham Co., VA. Hardin Woodrof or Woodroof**, son of David Woodrof, Sr.. was an orphan, whose guardian was James Nevil of Amherst Co., about 1759. He served in the American Revolutionary War as a corporal in **Capt. James Burton's** Company, 1st Va. Regt. He married in Buckingham County on 11 Oct 1784 Sally Gunter, b. 1760, daughter of Thomas Gunter.¹³

1782-1788 **Powhatan Co., VA. Charles Burton** is of this county.¹⁴

1782-1810 **Chesterfield Co., VA. John Burton** is of this county.¹⁵

1782-1812 **Buckingham Co., VA. Nathaniel Burton** is of this county.¹⁶

- 1783 **Chesterfield Co., VA. John Burton** bought 200 ac. from **Drury Hutchinson** and 100 ac. from **Thomas McDaniel**.¹⁷
- 1783 **Buckingham Co., VA. Robert Burton**¹⁸ bought 200 ac. from **John Douglas**.
- 1783-1809 **Buckingham Co., VA. Robert Burton** was of this county.¹⁹
- c.1785 **Buckingham Co., VA. Thomas Fearn**, son of John Fearn & Mrs. Leanna Lee, born in 1745, married **Mary Burton**, born 1751, daughter of **Col. Robert Burton** of Caswell Co., NC, and went to Danville (independent VA city) this year. "Col. Burton was one of those who aided in the settling and founding of Kentucky. He was the agent for the Transylvania Company." Thomas & Mary had son Robert (1795-1856).²⁰
- 26 Jan 1785 **Buckingham Co., VA. Jacob Burton** to **Ann Hambleton**, consent of **Samuel Hambleton**, father, Bondsman Benjamin Goss.²¹ They went to Georgia right away and later Arkansas.
- 28 Apr 1785 **Buckingham Co., VA. William Burton**, Dr. meaning debtor, ballance from an old acct. [account] for[ward]. £0.5.4.²²
- 09 Sep 1785 **Buckingham Co., VA. Robert Burton**, Dr. = debtor, for making a broad cloth wescott, £0.6.0.²³
- 1786 **Chesterfield Co., VA. John Burton, Sr.**, sold 80 ac. to **John Burton** of Chesterfield Co.²⁴
- 1786 **Buckingham Co., VA. Nathaniel Burton** received a new grant of 400 ac.²⁵
- 26 Jan 1786 **Buckingham Co., VA. Nath'l Burton**, 321 ac.; adjacent to **Edward Maxey, Widow Norcutt, Nath'l Maxey and Edward Maxey**.²⁶ NOTE RECORD BELOW:

Nathaniel Burton** signed a petition of residents of Buckingham to the General Assembly to ask that the lands of the Glebe in Tillotson Parish be disposed of and the money arising from the sale be used for payment of parish levies or any other purpose deemed proper.³³ **John Burton** also signed.³⁴

- 1798 **Buckingham Co., VA. Nathaniel Burton** bought 350 ac. from **George Babar.**³⁶
- 11 Feb 1799 **Buckingham Co., VA. Thomas Branch, Sr.**, of Hannah Springs conveyed 24 acres of land to

- 1813/1814 **Buckingham Co., VA. Benjamin Burton**'s 90 ac. in Muddy Creek (10NE) are in the possession of the **Nathaniel Burton** estate.⁶¹
- 1813/1814 **Buckingham Co., VA. Robert Burton** estate was on the James River (25N), residence of his widow.⁶²
- 1814 **Buckingham Co., VA. Robert Burton** estate sold 93 ac. on James River (24NE) to **Joseph Hill**.⁶³
- 1814 **Buckingham Co., VA. William Burton** sold 125 ac. on Muddy Creek to **Ballard Ford**.⁶⁴
- 1814 **Buckingham Co., VA. William Burton** resided on 120 ac. near Buckingham Courthouse, with another 60 ac. in a location not specified..⁶⁵
