In 1789, he was listed with two tracts, one of 100 acres, and one of 76 acres. A note listed the 76 acre tract as a new grant. For the years 1789-1801, John Sanderson was listed with the same two tracts, one of 100 acres, and one of 76 acres. No other Sanderson was listed in the land tax records for those years.

One land grant found for John Sanderson in Buckingham County. It was recorded in Grants 12, pg. 361, and dated 22 August 1787. It was described as beginning at Nathaniel Maxey's pointer. The survey was dated 26 January 1786.

Using the few texts available for Buckingham Co., researcher, James E. Ward, Sr., CG, found John Sanderson listed in 1788 and 1794. In 1788, he was listed in the extant poll lists for two elections that year. In 1794, church records show that John Sanderson signed a petition in which the parish was asking for permission to sell Glebe land as the minister had died, and the buildings were decaying.

No Sanderson was listed in Buckingham County on either the 1810 or 1820 Virginia Census. In 1810, a John Sanderson was listed in Cumberland County. In 1820, a John Sanderson, a John Sanderson, Jr., and a John B. Sanderson were all listed in Cumberland Co., VA. Also listed in Cumberland were Thomas B. Sanderson, William B. Sanderson, and Willis Sanderson.
